6. Terms of Reference	
The draft amended terms of reference circulated prior to the meeting included, 4.3 In the event that a Chairman is not appointed at the time of a scheduled Consultative Group meeting, and no Vice-Chairman is available to act in their place, the relevant Harbour Master may assume the role of acting Chair for the purpose of facilitating the meeting. While the Harbour Master is acting as Chair, no formal votes on recommendations or decisions may take place. This arrangement is intended to enable the meeting to proceed in a functional capacity, ensuring information sharing and discussion.  4.4 If no Chairman is appointed after two consecutive meetings where the Harbour Master has acted as Chair, the matter shall be referred to the Harbours Advisory Committee for further direction, including the possibility of nominating a suitable temporary Chair from

7. Marine Police update & Harbour Watch	
There have been no reported marine crimes in Lyme Regis area.	
The DNA tagging event held recently at the Sailing Club went well. 28 items were tagged. SH – The event was in very short notice, the officers were given some extra resources which enabled them to attend however only 1 code marker was used. The data is held with the Sailing Club.	
SH – To follow up on coding marking solutions.	SH
DB – Expressed that he had invited this event on two separate occasions but received no response. It was suggested to hold another event when vessels are out of the water. JR - Will try to arrange this, along with Harbour Watch.  8. Harbours Advisory Committee Chair's updates	JR
Two new non-elected members of the HAC have been appointed, both have great	
previous experience, and the HAC is now at full strength.	
Appointed members are, Mark Roberts and Lee Hardy.	
9. Harbour Masters update  The mooring occupancy is currently around 82%. There is a steady flow of new mooring holders coming in from invitation from the waiting list.	
North wall timber piles are completed.	
Depth gauge boards at the end of pier and north wall are completed, they are set at chart datum.  Please be aware that there could be some silting around the base of the wall and the	
depth can vary, ½ m now and ¾ m around pontoons.	
Dredging, the habitat risk assessment has been done, we are now waiting decision from Natural England.  The Water injection here is only a trial will not be a full dredge as we currently have no licence. If this goes well, we will then put in a full application for a licence.  This new process if approved will save around £60,000 to £80,000	
NM – Added that the TC have not funded their historical contribution this year.  JR – Added that the FCERN team are not receiving funding from the Environment Agency this year either. DC are looking at other options.	

- NM Without the sand replenishment, this will go over time.
- JR Yes but will be replaced with pebbles.
- RK The sand there now is integral for the under-pinning support; things could go wrong.
- EC The new method will only move sand 50m to 100m away then resettle,
- JR The beach works, sand replenishment will be dealt with by the engineers.
- SH Asked if a letter can be written to TC to express the groups concerns?
- JR will pass over to engineers.
- PF Suggested the placement of a timber wall.
- JR Engineers are looking into that option.
- EC The FCERN team are currently in discussion and drawing up concept costs.

The new JCB arrived Friday 9th May, we will be able to begin boat lifting within 1 week.

Our new services are available, providing petrol and diesel.

- NM Was there a big investment in this?
- JR No, we were given a trailer, and a vehicle is on order.
- PO This is suitable for larger vessels, with the standing charge and fuels costs, could you store fuel for smaller vessel owners to take away on purchase?
- JR We can currently store 330litrs, we can look at the price structure to accommodate.

- SH Are there any electrical charging facilities?
- EC Not now, it is in our longer-term plan.

Flares, our facility is now open to collect unwanted or out of date flares.

- DB Can the poster can be amended to include the cost of new flares?
- JR The cost varies, ordering in bulk will make it cheaper, let us know if you would like them.

## 10.Phase 5 update

FCERM Engineering update,

Currently, there is a funding shortfall to deliver the scheme, but the project team are progressing discussions with potential funders with the intent to close the funding gap.

The project team has recently completed a further value engineering design as part of the pre-construction stage. In addition, this stage has completed formal pre-application service engagement with Historic England and Natural England and provided updated construction cost estimates with specialist Contractor advice. The project team are continuing discussions with Historic England for further pre-application advice, and we are awaiting feedback, prior to procuring consultancy services for detailed design.

Construction is anticipated to commence Autumn 2026. It is our intention to hold public engagement and awareness sessions later in the year. These events will also explore how and when commercial users in particular access the Cobb and how access can be reasonably maintained – this information can hopefully help find the least disruptive solution to facilitating construction.

**Non-Commercial Moorings** –There are concerns from mooring holders regarding the lateness of dredging. 2 vessels have already been grounded.

**RNLI** - Events planned for the year are the annual Blessing of the Boats service at 3pm on Sunday 28<sup>th</sup> May, a concert by the Taunton Deane Male Voice Choir in aid of the RNLI at 7pm on Sunday 1 June in the Marine Theatre, and Lifeboat Week from Saturday 26<sup>th</sup> July until Friday 1<sup>st</sup> August.

**LRSC** – Concerns were raised around dredging; this is limiting movements.

Concerns were raised around launching from the slipway, there are very large vessels being launched and some near misses have been reported. The larger vessels are becoming a safety issue.

Could we ask for a little more consideration around the times of youth groups launching. The club's operational policy has been sent to HM office.

JR – Will investigate this to see what we can implement.

**BBA** – The next launch will be on 26<sup>th</sup> June at 8:30am, there are 5 vessels, we are impressed by the expertise of the students with this production.

**Boatman/Charters** – A Facebook post appeared showing the concerns of the dolphin and harassment, the post also advised any interactions are to be reported to the HM. The dolphin is very friendly and is playful, it approaches vessels for fun and there has been no harassment witnessed.

JR – Intentional interaction isn't allowed, the MMO is currently looking into this.
